With all due respect, we request that Resolution 72-3/15 regarding Lake Geneva's TID #4 be withdrawn from the March 10, 2015 County Board agenda.

We are perplexed that we were not extended the courtesy of notification that the Walworth County Finance Committee was considering Resolution 72-3/15 prior to taking action at their February 10th, 2015 meeting until receiving Mr. Bretl's letter dated February 25, 2015.

The City of Lake Geneva needs to ensure that it maintains its position as a premier tourist destination and upholds the Walworth County Tourism Bureau's slogan "Walworth County, Lake Geneva & Beyond".

The Lake Geneva City Council has scheduled a TID Workshop for Saturday March 14th to discuss the future of TID #4 and a copy of the agenda is attached for reference.

We respectfully request that the County Board postpone action on Resolution 72-03/15 until the April 21st, 2015 County Board Meeting.
