# Walworth County Board of Supervisors Finance Committee Meeting Minutes Thursday, January 19, 2023

Chair Sheila T. Reiff called the meeting to order at 10:03 a.m.

Roll call was conducted and the following members were present, either in person or by remote attendance: Chair Sheila T. Reiff; Vice-Chair Joseph H. Schaefer; Supervisors Kathy Ingersoll, Dennis Karbowski, and Rick Stacey. A quorum was declared.

## Others in Attendance

On motion by Vice-Chair Schaefer, second by Supervisor Stacey, the agenda was approved with no withdrawals.

On motion by Supervisor Karbowski, second by Vice-Chair Schaefer, the December 15, 2022 Finance Committee meeting minutes were approved.

**Public Comment** – There was none.

#### **Consent Items**

7a. Budget Adjustments/Transfers 2022

- 1) Lakeland Health Care Center
  - a. LH002 Adjust for insufficient equipment depreciation

Director-Health and Human Services/Superintendent of County Institutions Carlo Nevicosi stated the shortfall in funds for 2022 was the result of an inaccurate estimate of useful life for network switches and the call light system at Lakeland Health Care Center. Nevicosi advised that the budgeting shortfall has been mitigated in the 2023 budget.

Director-Finance Jessica Conley provided a detailed overview of her Memorandum included on Pages 12-18 of the packet; highlighting the efficiencies and cost savings attributed to a change in timekeeping software from UKG/Kronos to Munis/Enterprise. Discussion then focused on the benefits of utilizing products offering a regularly updated enterprise level system.

b. Lakeland Health Care Center – Resident therapy services

Nevicosi apprised the committee that the current resident therapy services vendor, utilized by Lakeland Health Care Center, gave notice that they would not be renewing/extending their contract beyond February 28, 2023. Nevicosi explained that the short timeline did not allow for the full Request for Proposal (RFP) process. The waiver of competition allows a one year contract with a new vendor, with the intent to put out a RFP for resident therapy services next year. Supervisor Stacey offered a motion, second by Vice-Chair Schaefer, to approve Consent Items, Item #7a, Budget Adjustment/Transfers and, Item #7b, Purchasing Reports. Motion carried 5-0.

# 7c. Reports

1) Update on tax incremental financing districts (TIDs)

Conley stated the City of Elkhorn Administrator informed her that one of the Citizen Members on their Joint Review Board for Tax Incremental Financing District (TID) #4 has resigned, and they will be advertising to replace the vacancy. The Administrator disclosed to Conley that the City of Elkhorn will be looking to amend their current project plan and make multiple changes to TID #4. The amendment removes all industrial construction from the TID, leaving only residential and commercial construction. The City has a developer looking to build approximately 850 market rate residential units with zero workforce units. Conley explained that workforce units are more affordable housing. Discussion ensued. The Committee agreed that the inclusion of workforce units is of extreme importance, and requested that Conley advise the City of Elkhorn that to exclude workforce units may affect the County's vote relative to a TID amendment.

Walworth County Treasurer Valerie Etzel indicated a significant decrease in delinquent tax amounts due to the County collecting back taxes on a parcel in the Village of Williams Bay.
